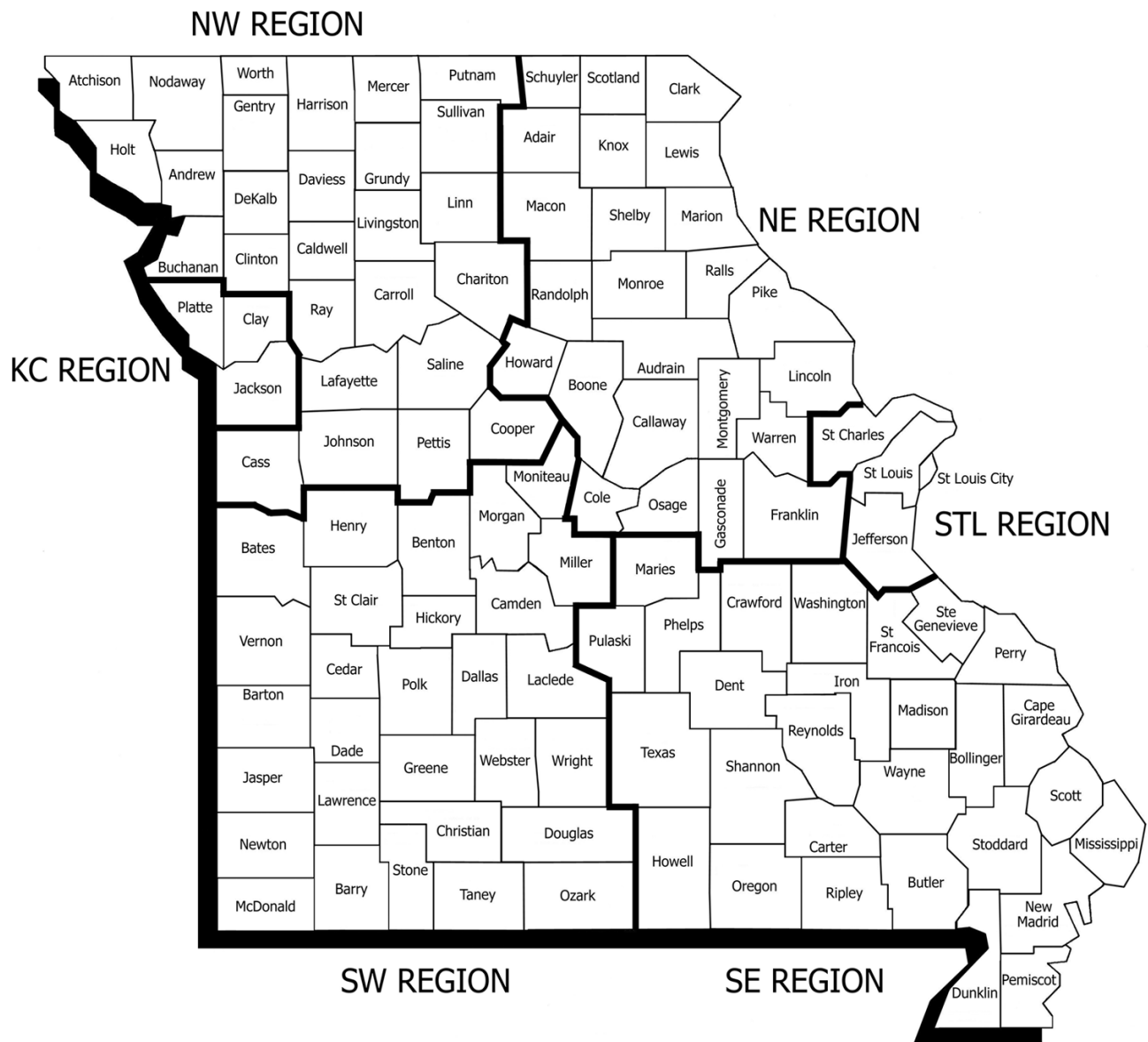

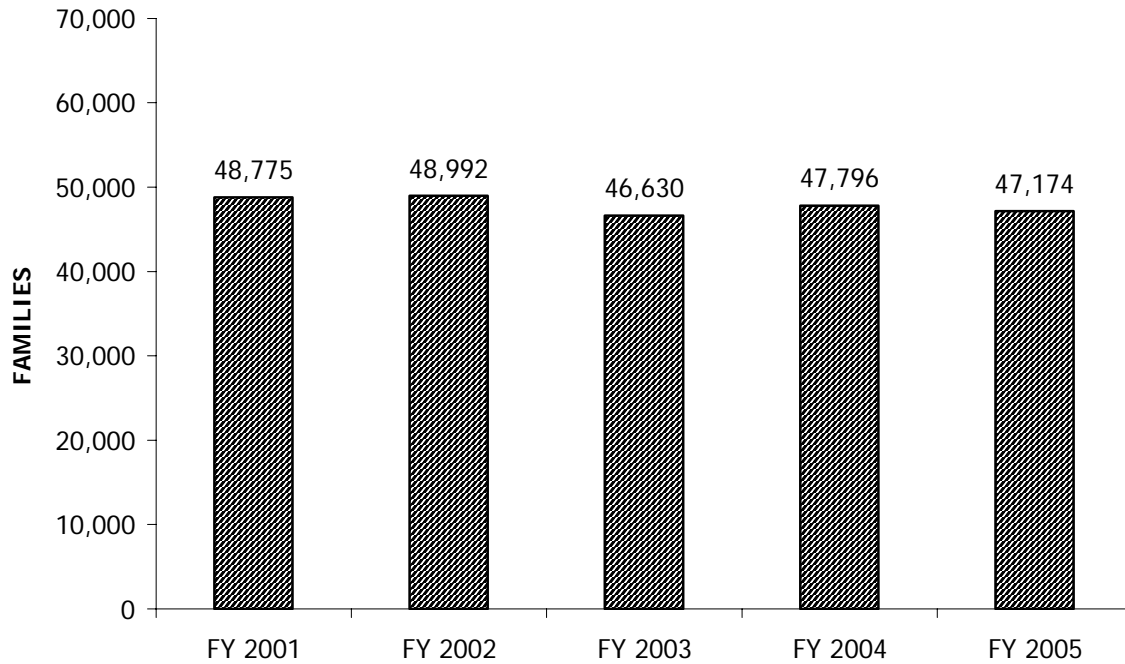

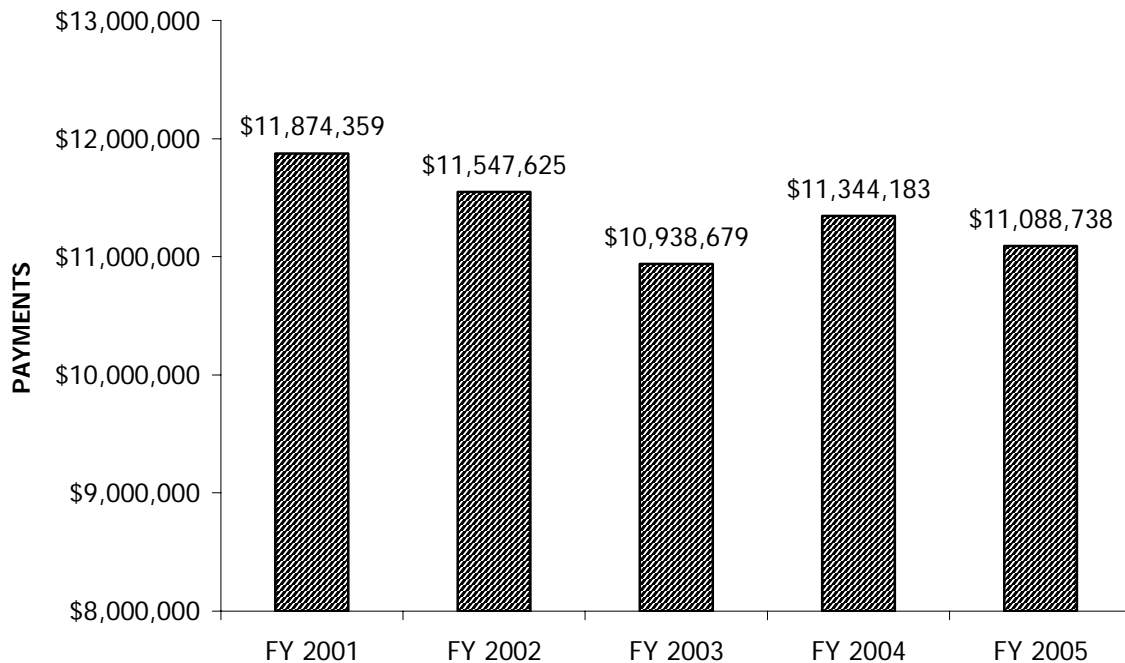

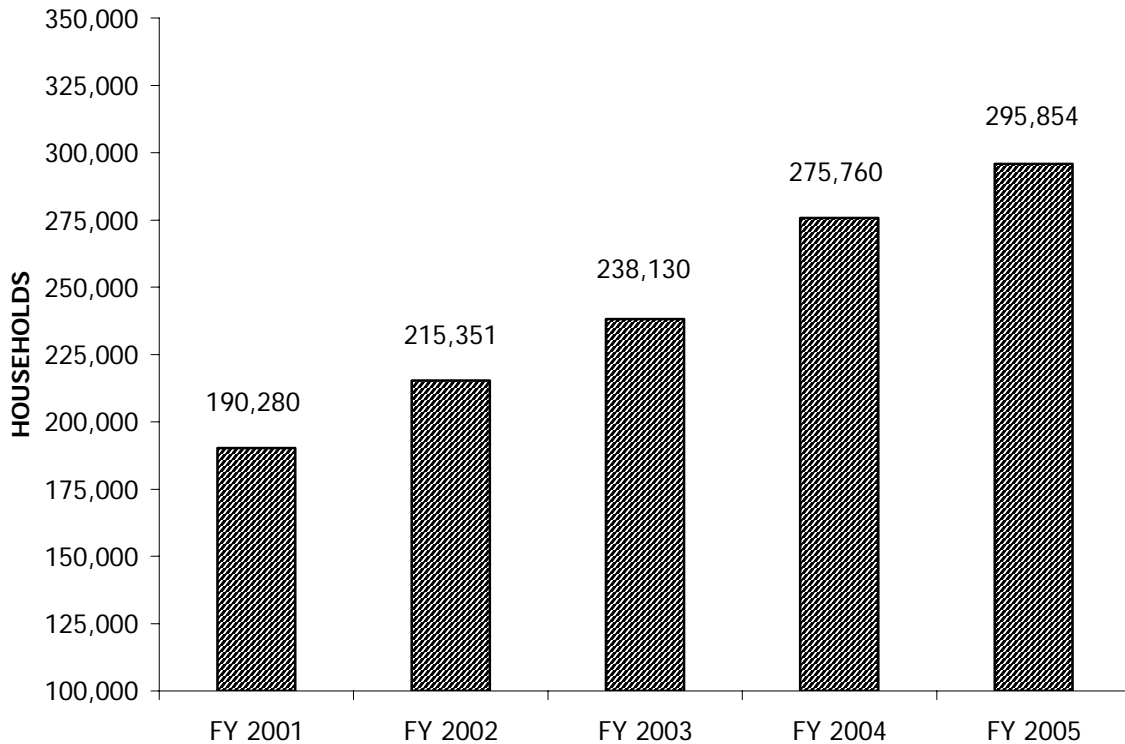

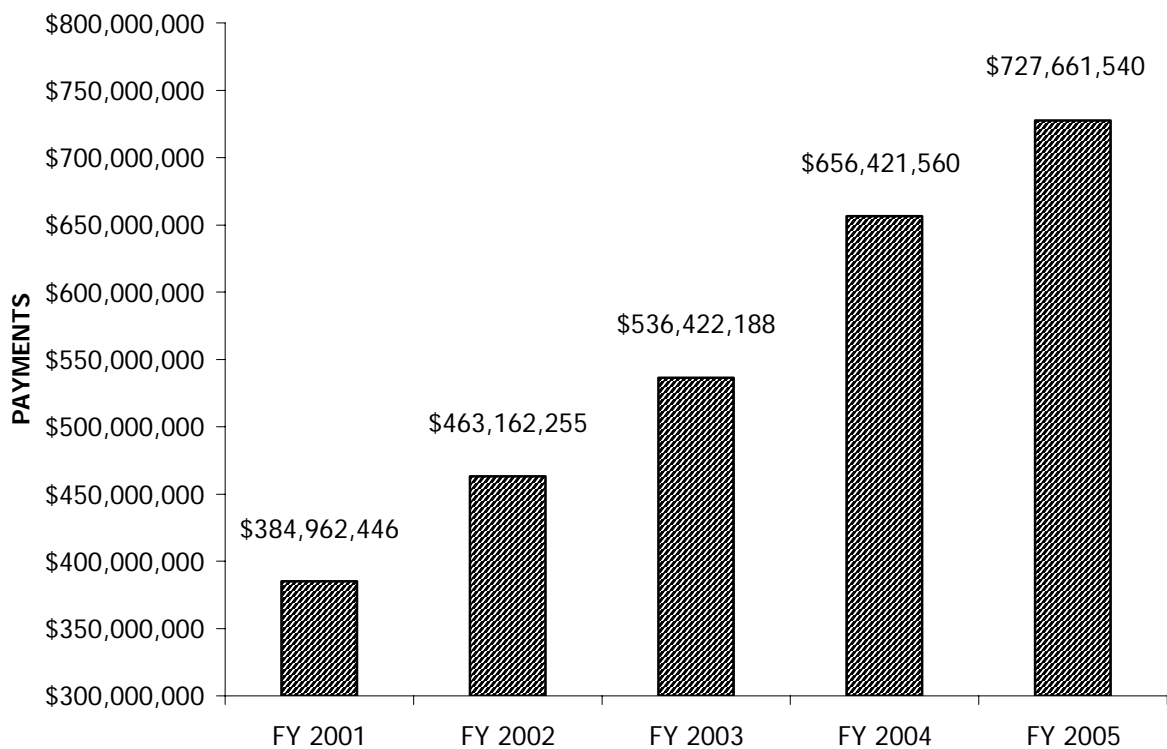




**Figure 5. Food Stamps**
